

Privacy Policy

CADapplet.com respects your privacy and is committed to protecting your personal information that you provide to us. This Privacy Policy explains our policies and practices regarding the use and disclosure of your personal information. CADapplet.com reviews and updates this Privacy Policy from time to time as needed without notice. Therefore, you should review the terms of this Privacy Policy periodically so that you are aware of how we collect and use personal information. By using our website, you consent to the collection, use, and disclosure of your personal information by CADapplet.com, as explained below.

Personal Information

In general, you can visit our website without providing us with any personal information. Disclosure of Personal Information

CADapplet.com may share personal information with companies that are affiliated with us (that is, that control, are controlled by, or are under common control with CADapplet.com) for

marketing, advertising or product/service offering purposes. If CADapplet.com sells all or part of its business or makes a sale or transfer of assets or is otherwise involved in a merger or business transfer, we may transfer your personal information to a third party as part of that transaction. We disclose personal information if: we have your consent; we need to share it in order to provide you with the products and/or services you requested; we respond to a court order or in order to comply with the law, or you violate our Terms of Use. CADapplet.com may share your personal information with service providers that perform services for us, such as providing hosting services, marketing assistance, analyzing user data, processing payment card information, and for other legitimate purposes permitted by applicable law. If you agree to provide such information to these service providers directly, then your personal information will be subject to their privacy policies and terms of use.

Accuracy and Security
